2 Before promoting them, it should be ensured that they fulfill the following requirements:-

- They are confirmed in the entry grade or in the present rank.
- They have successfully completed the promotion cadre course of Inspector/Fire.
- They are in medical category SHAPE-I.
- No Disciplinary case is pending against any one of them. Promotion should also not be given during currency of punishment.
- No fresh complaint has originated against the personnel and no fresh enquiry has been initiated or pending against the personnel.
- If any one is unwilling to move on promotion due to his own volition, a certificate to this effect (duly signed by the authority concerned that he is willing to forego his promotion and will not claim seniority), may be obtained and forward to FHQ (Estt-I Section)
- The promotion is without prejudice to the claim of other SI/Fire whose formal order for promotion to the rank of Insp/Fire are being issued separately. Their inter-seniority will be in order of panel drawn by the DPCs.

3 The Unit Commandants (Appointing Authority) will issue Unit Service Order Part-I indicating the PSL/FSL Number of SI/Fire(Lab& Mech) & date of promotion/assumption of charge in the rank of Inspector/Fire and will invariably forward copies of the S.O.part-I to FHQ (Estt-I/Estt-II and R&S Branches). In the promotion order, it may be mentioned that Govt. Servant has to exercise the option within one month for fixation of his pay under FR-22.
